By virtue of the authority vested in me by the Constitution and Laws of the State of Louisiana, I will sell at the principal door of the West Feliciana Parish Courthouse Annex in which the Civil/Tax Division is located, within the legal hours of Judicial Sales beginning on WEDNESDAY, JUNE 4, 2025, at Ten (10) O'CLOCK AM and continuing until the sales are completed, all immoveable property on which taxes are now due to the State of Louisiana, the Parish of West Feliciana, to enforce the collections of taxes assessed for the year 2024 together with interest thereon from the 1<sup>st</sup> day of January 2025 until paid and all costs.

The attention of mortgage creditors is especially called to said advertisement of tax sales and they are warned to take such steps prior to the sale as may be necessary to protect their rights.
